1. Introduction

By registering for a proprietary trading account or using our services—including algorithmic add-ons—you ("User", "Trader", or "Client") acknowledge and agree to be bound by this Agreement.

LTJ Manager LLC is a company registered in Saint Vincent and the Grenadines, company number 4156 LLC 2025, with its registered office at Euro House, Richmond Hill Road, Kingstown, St. Vincent and the Grenadines.

2. Definitions

Proprietary (Prop) Trading Account: A simulated account provided for training, evaluation, and strategy testing purposes under strict risk guidelines.

Algorithm Service: A proprietary tool offered to assist in trade analysis, signal generation, and optional automation.

Dashboard: The online user portal where account information, analytics, and tools are accessed.

3. Eligibility

Users must:

Be at least 18 years old.

Be legally capable of entering binding contracts.

Provide accurate registration information and comply with applicable laws and platform policies.

4. Services Offered

4.1 Simulated Trading Account

LTJ Manager provides access to simulated trading accounts. These accounts:

Are not funded with real money.

Are used for performance evaluation and training only.

Operate under predefined risk rules, including daily loss limits and maximum drawdown thresholds.

Allow traders to earn profit shares based on simulated performance (standard 80/20 split in favour of the trader).

4.2 Algorithm Add-On (Optional)

Traders may subscribe to an optional algorithmic trading service, which:

Supports signal generation, trade execution, and/or risk scoring.

Is operated by LTJ Manager or used manually by the trader.

Is provided as-is with no guarantee of performance.





5. Use of the Algorithm

5.1 License

LTJ Manager grants a limited, non-exclusive, non-transferable license to use the algorithm only within the LTJ Manager platform.

5.2 No Warranty

The algorithm is provided without any warranties of profitability or accuracy. You assume full responsibility for its use.

5.3 Prohibited Use

You may not:

Reverse engineer, copy, distribute, or sublicense the algorithm.

Use it outside the LTJ Manager platform.

Engage in unethical or manipulative trading behaviour.

6. Fees

6.1 Program Fees

Users may be charged a one-time fee to access a simulated trading program. This fee is for evaluation services only and is non-refundable.

6.2 Operational Costs

LTJ Manager may deduct platform or technology-related costs from any profit share owed to the trader (if applicable).
